



11th TERRITORIAL SKILLS COMPETITION - SCOPE DOCUMENT

29 - HAIRSTYLING Secondary and Post-Secondary Levels

PURPOSE OF THE CHALLENGE

DURATION: 4 HOURS

To enable the industry as well as observers to view the level of skills taught within the public, secondary and post-secondary programs and to encourage interaction between the various sectors. This relationship will ensure the skills gained by young hairstylist at all levels of training are geared to the demands of the beauty industry.

SKILLS AND KNOWLEDGE TO BE TESTED

The level of this competition will allow the young stylists to demonstrate their technical skills and creative ability in the following two tests.

- Ladies cut and day style.
- Day style transformed into a cocktail style.

NOTE: Colors may be done beforehand although this is not necessary. No written test will be administered. The theoretical knowledge will be relevant in the performance of the practical tests.

Ladies cut and day style

Duration: 2 hrs.

A cut will be performed. In no case will the finish be fussy or over sprayed.

Haircut

- The hair must be cut, but the cut will not be marked.
- The style is of the competitor's own choice but should follow the international trends.

Blow-dry

- The competitors perform blow-dry on wet hair.
- The competitors proceed to start on the competition floor with wet hair, combed straight back.
- All tools are allowed, as well as all fixing products.
- Mannequin hair must be a minimum of 8" in length all over the head prior to the start.
- Mannequin draping is encouraged.

Scoring

- International system 30 points

Criteria

- Balance and form
- Cleanliness of finish
- Originality of design
- Artistic Impression

Ladies by night style (cocktail style)

Duration: 2 hrs

- This competition is a cocktail style.
- The mannequin from test # 1 goes back to the competition floor and restyled into the cocktail evening style.

- The competitors can, if they wish, wet, shape, blow-dry or style the hair during the time allocated for performing their hairstyle.

Scoring

- International system 30 points

Criteria

- Balance and form
- Cleanliness of finish
- Originality of design
- Difficulty and overall creativity

NOTE: Participants will not be judged on color.

EQUIPMENT, TOOLS, SUPPLIES, AND CLOTHING

Provided by the competitor:

- All working tools including hot tools, cutting implements, brushes, combs, etc
- All styling products
- Clean and comfortable work attire as would be worn in a modern hair salon as well as any protective clothing if needed
- Encouraged to provide jewelry, draping and hair ornamentation for the mannequin
- Your preferred types of styling products
- Do not provide any make up on mannequin

Provided by the committee:

- One competition mannequin: long hair female
- Towels, cape
- A table and mirror, non-hydraulic chair, and double electrical outlet provided.

SAFETY REQUIREMENTS

Failure to comply with any safety regulations may result in disqualification or removal of competitor from competition.

JUDGING CRITERIA

All judging will be performed according to the IVTO (World Skills) Point System.

The contestants with the highest combined points from the two tests will be the winner, the second highest mark will be placed second, and the third highest mark will be third.

Demerits may be given for any rule infraction(s).

Any communication between audience and competitor during contest times may be seen as coaching and could warrant demerits.
